## **REPORT**

On 7<sup>th</sup> May 2016 Stewards finalised an Inquiry into an alleged altercation that occurred at The Meadows on 19<sup>th</sup> December 2015 between Mr Bernard Courts and another registered person.

Initial evidence had been taken at The Meadows on 19<sup>th</sup> December 2015 from three MGRC employees, Mr Bernard Courts, Mr B. Meachem and Ms. T. Stevens before the matter was adjourned to a date to be fixed.

After providing evidence on 19<sup>th</sup> December 2015 Mr Bernard Courts relinquished his registration to Stewards. Acting under LRR 11.4 Stewards deemed the registration of Mr Courts to be cancelled from that time.

Whilst the Inquiry was scheduled to reconvene on 27<sup>th</sup> February 2016, an adjournment was granted at the request of Mr Bernard Courts due to his ill health requiring hospitalisation.

On 7<sup>th</sup> May 2016 the Inquiry was reconvened and further evidence was taken from Mr Bernard Courts, Mr B. Meachem and Ms T. Stevens. After considering all evidence, Stewards charged Mr Bernard Courts with a breach of GAR 86 (q), the particulars being that at The Meadows on 19<sup>th</sup> December 2015 Mr Courts had engaged in a physical and verbal altercation with another licensed person (B. Meachem) which was detrimental to the interest, image and control of greyhound racing.

Mr Courts pleaded guilty to the charge.

Stewards found Mr Courts guilty as charged and issued the following penalty:

- \$750 fine
- 3 months disqualification, suspended for 2 years pending no further breaches of GAR
   (g) or (g) for offences involving physical or verbal altercations.



In assessing penalty, Stewards took into account the following factors:

- Mr Courts's guilty plea.
- Mr Court's demonstrated remorse.
- Mr Courts's apology to the other party, which was accepted.
- The fact that Mr Courts's registration has effectively remained cancelled since 19<sup>th</sup> December 2015.
